Minutes of AGM, 18th November 2024

Meeting commenced at 7.36pm

- 1. Attendees welcomed by President, Di Cooper.
- 2. Minutes of 2023 AGM had been published on website. Taken as read.

Moved: That the minutes be accepted. (W Gross), Seconded: Paul Lucas. Passed.

- 4. Treasurer's Report-

The operating result for the year was a surplus of \$6,832 (last year \$11,708), which is the sort of result a Club such as ours seeks to achieve (i.e. a small operating surplus).

In a trend being experienced by the majority of car clubs, membership fees and joining fees received in FY24 declined 8.1% or \$4,104 to \$46,507.

Various social events were held throughout the year which resulted in a net deficit of \$4,932, (compared with a deficit of \$10,927 last year). Meanwhile, members contributions to events fell 12% from \$34,026 last year to \$29,867 this year. Expenditure on the club magazine was \$25,552 (last year \$24,036). At the timeof writing, there are 411 paid up members, meaning the cost of each magazine is just over \$10.00 per magazine per member delivered, with postage and handling being around 23% of the cost.

Your club remains in a sound financial position and at year end had cashholdings of \$185,788 (last year \$179,632). Cash balances include between \$40,000 and \$50,000 held in the seven regional register accounts. At the time of writing, cash holdings were a little over \$160,000 with \$105,000 of this invested with Macquarie Bank in an accelerator account which is at call, currently earning 4.75% pa.

Barrie asked for questions:

- Neil questioned our holdings of \$160,000. Management Cttee will discuss reducing those over the next year
- Neil raised questions about Public Liability insurance, including the brokerage cost and premium. Concern about difference in coverage for those under 80 and those over 80. Management Ctte to revisit this. Wendy to send a copy of Insurance Policy to all Registers.

Moved: That the 2023-2024 Financial Statements be accepted (Barrie Fletton). Seconded: Neil Summerson. Passed
